In relation to Section 4.10 of the MERJ Listing Requirements, Cable & Wireless Seychelles would like to inform all affected persons that it will be in a closed period for the trading of its shares with immediate effect until such a time as the interim results for the six-month period ending 30 June 2023 are published. Cable & Wireless Seychelles anticipates that the results will be released by the 29<sup>th</sup> September 2023.

During this period, all affected persons are prohibited from dealing in Cable & Wireless Seychelles' shares, as it could be implied that they may be aware of unpublished price-sensitive information. Unpublished price sensitive is information affecting a company which if released is likely to materially affect the company's share price.

For the ease of reference, the definition of "affected persons" is included below:

"affected person" means in relation to Cable & Wireless Seychelles:

- a) any officer or other person employed by Cable & Wireless Seychelles in a managerial or executive capacity; or
- b) any officer of person employed in the finance department of Cable & Wireless Seychelles; or
- c) Cable & Wireless Seychelles' board of directors; or
- d) any member of Cable & Wireless Seychelles' executive management team or
- e) any officer or other person employed by the company sponsor advisory, external auditors, or external company secretary who works on Cable & Wireless Seychelles' accounts; or
- f) any of the following in relation to any of the persons prescribed in a) through c)-
  - i. an associated person; and
  - ii. that person's spouse; and
  - iii. that person's child, parent, step-child, or step-parent and any spouse of such person; and
